Hong Kong designated policyholders

Further to our notification to impacted policyholders and advisers in August 2024 regarding regulatory changes which requires Friends Provident International Limited ("FPIL") to segregate all Hong Kong designated policyholder assets from those of other jurisdictions, the segregation of Hong Kong assets took place with effect 25 November 2024.

The FPIL fund codes on the mirror funds that are available to Hong Kong designated policyholders have now changed as per the tables below.

Please note that Hong Kong Onshore designated policyholders are only allowed to invest new premiums and switch into mirror funds authorised by the Securities and Futures Commission ("SFC") in Hong Kong.

The following funds with a FPIL fund code of H and X are available to both Hong Kong Onshore designated policyholders and Hong Kong Offshore designated policyholders for new premium investment and switches-in. These funds are authorised by the SFC in Hong Kong.
