

Mirror Fund Guide for Hong Kong Offshore policyholders

September 2026



Friends Provident International Limited (FPIL) has prepared this guide to help you choose the mirror funds that can be accessed via our investment-linked products.

This guide is applicable to policyholders designated as Hong Kong Offshore. There are different guides available for policyholders designated as:

- Rest of World
- UAE
- Hong Kong Onshore
- Singapore

You should read the guide that is relevant to you to ensure you view the range of funds that are applicable to your policy and region designation.

Friends Provident International Limited (FPIL) operates a range of funds known as mirror funds. The concept is simple: agreements have been set up with investment houses worldwide allowing us to link to specially selected funds chosen on the basis of performance and investment expertise (we refer to these fund links as the “underlying funds” of the mirror funds).

The mirror funds can only be accessed using FPIL unit-linked investment products.

This guide has been produced to help you choose the mirror funds you would like to include as investments in your savings plan and should be read in conjunction with the relevant product literature. We provide you with an online Fund centre, which is an interactive research tool where you can monitor performance of the mirror funds and view fund fact sheets. This will provide you with the necessary information to help you with your investment decisions. Access to the Rest of World interactive Fund centre research tool can be found under the “Funds” drop down on our website at www.fpinternational.com

Fund Charges

Charges are deducted by both FPIL and the underlying fund investment managers at each valuation point before calculating the unit price.

FPIL charges (payable directly by you)

- You will need to pay an annual mirror fund administration charge of 1.2%.
- There is no charge for switching funds, although switching to a fund whose currency differs from the currency of your plan, may involve a cost associated with currency exchange. However, we reserve the right to charge for switches under certain conditions. Please refer to the policy conditions for further details.
- Any sales and/or redemption charges will be determined by the terms of your policy conditions.

Underlying fund investment managers' charges (payable by the mirror fund)

These charges are payable by the mirror fund from invested proceeds.

- The annual charges charged by the underlying funds can be found in the table on the following pages. Please refer to the Ongoing Charge % column.

Risk Rating - guide to the risk/reward profile of our mirror funds

Each mirror fund has a risk/reward profile determined by FPIL using information provided by the management company of the underlying funds. It is based on the following characteristics of the underlying funds:

- volatility
- asset type
- geographical region.

The risk/reward profile will be reviewed and, if appropriate, revised at least yearly by us as a result of our ongoing research analysis. The information given in the risk/reward profile is for reference only. Please refer to the Risk Rating column in the following table for the rating applicable to each mirror fund.

Grade 1: These funds offer a conservative return similar to money market rates.

Grade 2: Low risk funds offering security and potential growth.

Grade 3: These funds take a balanced approach to investment by holding a diverse portfolio of assets.

Grade 4: These funds have a more focused asset exposure providing good growth potential with the risk of short-term volatility.

Grade 5: These aggressive funds balance the risk of high volatility with the potential for high capital growth.
